Mark schemes are prepared by the Lead Assessment Writer and considered, together with the relevant questions, by a panel of subject teachers. This mark scheme includes any amendments made at the standardisation events which all associates participate in and is the scheme which was used by them in this examination. The standardisation process ensures that the mark scheme covers the students' responses to questions and that every associate understands and applies it in the same correct way. As preparation for standardisation each associate analyses a number of students' scripts. Alternative answers not already covered by the mark scheme are discussed and legislated for. If, after the standardisation process, associates encounter unusual answers which have not been raised they are required to refer these to the Lead Examiner.

It must be stressed that a mark scheme is a working document, in many cases further developed and expanded on the basis of students' reactions to a particular paper. Assumptions about future mark schemes on the basis of one year's document should be avoided; whilst the guiding principles of assessment remain constant, details will change, depending on the content of a particular examination paper.

Level of response marking instructions

Level of response mark schemes are broken down into levels, each of which has a descriptor. The descriptor for the level shows the average performance for the level. There are marks in each level.

Before you apply the mark scheme to a student's answer, read through the answer and annotate it (as instructed) to show the qualities that are being looked for. You can then apply the mark scheme.

Step 1 Determine a level

Start at the lowest level of the mark scheme and use it as a ladder to see whether the answer meets the descriptor for that level. The descriptor for the level indicates the different qualities that might be seen in the student's answer for that level. If it meets the lowest level then go to the next one and decide if it meets this level, and so on, until you have a match between the level descriptor and the answer. With practice and familiarity you will find that for better answers you will be able to quickly skip through the lower levels of the mark scheme.

When assigning a level you should look at the overall quality of the answer and not look to pick holes in small and specific parts of the answer where the student has not performed quite as well as the rest. If the answer covers different aspects of different levels of the mark scheme you should use a best fit approach for defining the level and then use the variability of the response to help decide the mark within the level, ie if the response is predominantly level 3 with a small amount of level 4 material it would be placed in level 3 but be awarded a mark near the top of the level because of the level 4 content.

Step 2 Determine a mark

Once you have assigned a level you need to decide on the mark. The descriptors on how to allocate marks can help with this. The exemplar materials used during standardisation will also help. There will be an answer in the standardising materials which will correspond with each level of the mark scheme. This answer will have been awarded a mark by the Lead Examiner. You can compare the student's answer with the example to determine if it is the same standard, better or worse than the example. You can then use this to allocate a mark for the answer based on the Lead Examiner's mark on the example.

You may well need to read back through the answer as you apply the mark scheme to clarify points and assure yourself that the level and the mark are appropriate.

Indicative content in the mark scheme is provided as a guide for examiners. It is not intended to be exhaustive and you must credit other valid points. Students do not have to cover all of the points mentioned in the Indicative content to reach the highest level of the mark scheme.

Section B

Dictation

The dictation is assessed for Communication of meaning (AO1) (4 marks) and Transcription and grammatical accuracy (AO3) (4 marks) as specified in the criteria below.

The maximum mark for Section B at Foundation tier is **8**. When awarding the marks for AO1 and AO3, the student's response across all the spoken extracts should be considered as a whole.

4	4	The meaning of the spoken extracts is always or almost always communicated clearly
3	3	The meaning of the spoken extracts is mostly communicated
2	2	The meaning of the spoken extracts is sometimes communicated

Notes

- When awarding a mark for AO1, you should consider the spoken extracts as a whole and decide to what extent their meaning is conveyed to a native speaker, regardless of how they have been transcribed. The key question to ask is: would a native speaker understand the meaning of the student's response, taking into account the context of the spoken extracts? Eg *Hier, j'ai jouer au football* – the meaning would be communicated despite the use of an infinitive instead of a past participle.
- Once you have decided on the mark for AO1, you should read through the whole transcription once more and decide on the mark for AO3.
- A mark of zero for AO1 automatically results in a mark of zero for AO3, but apart from that, the AO1 mark does not limit the mark for AO3.

- If a student leaves gaps in their transcription, you must assume that any attempt would have been highly inaccurate and award a mark for AO3 accordingly. Not to do so would penalise unfairly those students who make an attempt at transcription but whose transcriptions are highly inaccurate.
- Occasional minor errors in transcription do not preclude a top level mark for AO3; perfection is **not** required. Examples of minor errors could include wrong accents or spelling errors which change neither the meaning of the word nor the transcription of the correct sound-symbol correspondence eg *rêve* for *rêve*; *enuyeux* for *ennuyeux*. Numerous minor errors would have an impact on the mark for AO3.

Below are the dictation sentences for this exam:

- Sentence 1** J'aime bien / le cinéma.
- Sentence 2** Ma copine / est jolie.
- Sentence 3** Le lundi / on mange / du poulet.
- Sentence 4** Vous portez / une belle / chemise.

To exemplify the marking criteria and to assist examiners in accurate application of the criteria, a range of exemplar student responses has been provided below with a commentary.

Student 1

1. J'aime bien le cinema
2. Ma copine est joli
3. Le lundi on mange du poulet
4. Vous portez une bel chemize

Total marks awarded for Student 1 = 8/8

Commentary

The lack of accent on *cinema*, the incorrect adjectival ending on *joli* and the incorrect spellings of *bel* and *chemise* do not prevent the meaning of the spoken extracts to be communicated hence a mark of 4 is awarded for AO1.

A mark of 4 is also awarded for AO3. Overall, words have been transcribed correctly frequently and the level of grammatical accuracy is good at this level.

Student 2

1. J'aimes bien le cinema
2. Ma copaine es joli
3. Le lundy on mange du ...
4. Vous porter une bel chimise

Commentary

The gap in sentence 3 prevents this spoken extract from communicating. Despite grammatical inaccuracies in sentences 1, 2 and 3 and some incorrect spellings (*cinema, lundy, chimise*), the meaning of these spoken extracts is mostly communicated. As such, an overall mark of 3 for AO1 is awarded.

A mark of 2 is awarded for AO3. Overall, words are occasionally transcribed correctly (*bien, ma, on, mange, du, vous, une*) and the level of grammatical accuracy is limited (incorrect verb formations in sentences 1, 2 and 4 as well as incorrect adjectival formations in sentences 2 and 4 for instance).

Student 3

1. Jaim bein le cinema

Commentary

Despite the inaccuracies in sentences 1 and 2, the meaning of the spoken extracts would be communicated. On the other hand, the inaccuracies in sentences 3 and 4 do not allow the meaning of these extracts to be communicated. As such, a mark of 2 is awarded for AO1 as, overall, the meaning of the spoken extracts is only sometimes communicated.

A mark of 1 is awarded for AO3. Words are very rarely transcribed correctly, and the level of grammatical accuracy is very limited (only 1 verb formed accurately for instance).

Student 4

1. Jaim bien le cinema
2. Ma ... et jolly
3. Le landy on mange du ...
4. Vous porter une bell ...

Commentary

Overall, only the meaning of the first spoken extract is communicated clearly. The gaps and incorrect transcriptions in the other spoken extracts prevent their meanings being communicated clearly. As the meaning of the spoken extracts overall is rarely communicated, a mark of 1 is awarded for AO1.

A mark of 1 is also awarded for AO3. Words are very rarely transcribed correctly (including the transcription of several words having not been attempted) and the level of grammatical accuracy is very limited.
