From a report sent to a courtier in London from a royalist informant in the country, October 1637.

All things here are, at this point, calm, so there is very little matter new to write about, for all business with Ship Money goes on undisturbed and all men, for the most part, submit. And although demands for payments here are great (considering the people have not heretofore been accustomed to them) yet they only speak privately of discontent but still lay down their purses and pay. I think that great tax of the Ship Money is so well accepted I suppose it will become permanent. Time can change minds to accept public necessities. Thus, if men considered the great sums needed for service of the state, these Ship Money payments would appear a little burden.

SOURCE B

From a letter to his wife from Thomas Knyvett, a member of the Norfolk gentry, in London, November 1637.

The business now talked of in town is all about Ship Money. The King is willing to allow those who refuse to pay, whereof John Hampden is one, to have their lawyers to argue their case in point of law in the Court of Exchequer before all the judges. 5
Oliver St John hath already argued against Ship Money very boldly and bravely. Yesterday was the first presentation of the King's side. I cannot relate any particulars because I heard it not. Although I was up at dawn I was so far from getting into the 10
Court that I could not get near the door by two or three yards, the crowd was so great.
