SOURCE A

From a statement given to the press in Paris on the day before the Paris Summit, by Nikita Khrushchev, 16 May 1960.

Source A is not reproduced here due to third-party copyright restrictions

SOURCE B

From a confidential government report on the Paris Summit by the US Bureau of Intelligence and Research, 25 July 1960.

Khrushchev probably never considered the summit conference as an opportunity to strengthen Détente. He envisaged it as an opportunity for advancing Soviet foreign policy interests. The conference would probably have continued had the U2 Incident 5 not occurred, although had the USA been forced to acknowledge the flights at the conference, Moscow would gain an important psychological advantage. However, Khrushchev is likely to have calculated that if the conference collapsed, relatively little 10 would be lost. The USSR could have chosen to play down the incident until the summit was underway, but faced with the prospect of no tangible gains at the summit, Khrushchev welcomed the U2 Incident and the collapse of the summit as a means of 15 scoring personal success.
